# **New Business**

Mrs. Candy Maust, Supervisor of Instruction

 Elementary Education, and Mrs. Amy
 Warnick, Supervisor of Instruction Secondary Education, presented five sets of instructional materials to the Board for review. The instructional materials will be available for review online or at the Ruth Enlow Library of Grantsville and Oakland through April 1, 2025, before the Board takes action on these items at its April meeting.

### Policies and Procedures

- Mr. Jeff Gank, Director of Technology and Cybersecurity, presented the revised GBEE Acceptable and Responsible Use of Technological Resources for Employees Procedure to the Board.
- Mrs. Rebecca Aiken, School Health Nurse Manager, presented recommended revisions to the JLCC Communicable Diseases and Related Conditions of Public Health Importance Policy and Procedure. Mrs. Aiken also presented recommended revisions to the JLCDA Opiate Response Policy and Procedure.

Finally, Mrs. Aiken presented recommended revisions to the JLCEB Automated External Defibrillator Policy and Procedure.
She provided clarification and answered questions from the Board. These policies were a first read. The Board is expected to act on these during the April Board meeting.

## **Continuing Business**

- Dr. Jane Wildesen, Director of Human Resources and Chair of the Calendar Committee, recommended the Board approve June 12, 2025, as a revised makeup day for this school year, as February 17<sup>th</sup> was not utilized as a make-up day due to inclement weather. The Board voted unanimously to approve this make-up day.
- approve the proposed FY2025-26 School Calendar as developed by the GCPS Calendar Committee and revised based on feedback from the public. The Superintendent recommended approval of the post-Labor Day start for the calendar. There was a motion to change Veterans' Day to a day off from school, which failed after discussion. The Board voted 3-1 to approve the post-Labor Day calendar, attending a full day on Veterans' Day.

### **Superintendent Updates**

Dr. McCartney provided the following updates:

- She reminded the public that Science testing is underway for grades 5 and 8 students. The testing window is March 3-21, 2025. Please refer to your local school calendar for school-specific dates. Spring Administration of MCAP English Language Arts (ELA) Grades 3-8 and 10; and MCAP Mathematics Grades 3-8, Algebra I & II, and Geometry will occur April 7-May 30, 2025.
- She shared that GCPS outperformed all other districts in Maryland in both favorable student and educator perceptions.
- She also shared that GCPS is among four school systems across Maryland to achieve an impressive 95% graduation rate for the 2023-2024 school year, which is the highest rate the state awards.
