Policies and Procedures

 Mr. Richard Wesolowski, Director of Maintenance, Facilities, Operations, and Transportation, requested that the Board approve the revised EEBAA Vehicle Use Policy. The Board voted unanimously to adopt this policy.

Continuing Business

- Mr. Richard Wesolowski requested the Board approve the 2022 Educational Facilities Master Plan. The Board voted unanimously to adopt the 2022 EFMP.
- Grimm + Parker architects and design team members prepared the two educational specifications reports for the GCBOE. There was no formal presentation on this topic.
 These documents summarize in writing the presentation given at the August Board

Meeting. This information will be submitted to the Interagency for School Construction. Mr. David Wolf, Architect, G+P, and Mr. Richard Wesolowski, GCPS, answered questions from the Board.

Public Comment

- Parent Michael Kepple spoke to the Board in favor of the recommended grade-band alignment and facility modernization, and also applauded Grimm + Parker for their work on the project.
- Public citizen Michael Henderson questioned the definition of an adjacent school, questioned the school population after GBA, and suggested to the Board they consider a backup plan if funding does not come through as believed will happen.

Continuing Business

Ms. Barbara Baker, Superintendent, requested the Board approve the plan for modernization of Southern Middle School and to become a Pre-K to 6th-grade facility, Southern High School to receive limited renovation to become a 7th to 12th-grade facility, and Broad Ford Elementary to eventually be demolished. The Board voted 3-1 to approve the new grade-band alignment. They also requested a project manager to oversee these projects and that a feasibility study be completed for Crellin Elementary.
